4. You will then receive a confirmation email and the hand blender will be on its way!

Alternatively, call 0844 892 8989 to register your claim. Please note you will be required to send proof of purchase.

## TERMS AND CONDITIONS

1. The Promotion is the gift of a Bosch hand blender MSM7700 ("the Gift") from the Promoter on the purchase of selected Neff ovens with a Slide&Hide® door from **John Lewis, Appliances Online, Wren Kitchens and Homebase participating retailers** during the term of the Promotion and for which the Promoter has received a completed and valid claim form in respect of such purchase before 14/09/13. This is a consumer only promotion and the offer cannot be used in conjunction with any other offer.
2. The Promotion shall only apply to purchases of the following selected Neff ovens with a Slide&Hide® door: i) B46C74N3GB; ii) B46E74N3GB; iii) B46E54N3GB; iv) B45E54N3GB; v) B45E74N3GB; vi) B45C52N3GB; vii) B45E52N3GB; viii) B45M54N3GB; ix) B45M52N3GB; x) B44M42N3GB; xi) B44S42N3GB and xii) B44S32N3GB.
3. The Promotion shall not apply to purchases of graded, seconds, replacements and imperfect products or to trade and contract sales.
