Anyone purchasing a new Singer sewing machine from an authorised UK stockist between **27th April – 31st July 2016** will be able to enter the draw.

Each of the days will be divided into a morning and afternoon session, with up to seven different winners attending each session. The sessions are specially designed for all levels of sewing experience from beginners to experts. The winners will be invited to customise a garment or accessory of their choice with support from our Singer sewing experts who will be there all day to guide and advise. Patrick will be on hand to chat and offer his unique advice. At the end of the session he will comment and give guidance on each of the projects.

The winners for the sessions will be drawn from all entrants on Wednesday 3rd August 2016 at which point entry is closed.

## TERMS AND CONDITIONS OF ENTRY

1. The Competition is open to any purchaser of a new Singer sewing machine from an authorised UK supplier between 27th April – 31st July 2016 who is over the age of 18 and based in the UK. (to verify whether a supplier is authorised, please see our website [www.singerco.co.uk](http://www.singerco.co.uk))
2. Employees of Bogod Group Ltd, Singer Sewing Company or SVP Corporation or any of their affiliates or subsidiaries cannot enter.
3. The competition is "free to enter" in that no additional payment is required to enter other than the normal and usual cost of the eligible sewing machine from your chosen supplier. However participants are expected to pay their own cost of connecting to the website and in the event of them winning, their own travel costs to and from the location of the sewing session.
4. Entry can only be made through the form on our website and will be confirmed by email. Only one entry per machine purchased is allowed. If multiple entries are found to have been made, with or without the purchaser's knowledge, all associated entries will be disqualified.
